# 6. Reports from Committee Members KA

**Action** 

Spoke about NSW State election asks, specifically a commitment from all candidates to a gold level standard on new public and social housing. Coalition asserted that public housing was built to silver standard, no firm commitments from other parties.

#### ES

PDCN should be completing the usability report for the responsive website by the end of April.

 ES to submit report and tax invoice

#### SP

Providing feedback in getting home modifications via NDIS and Royal Commission is aiding in that cause. Royal Commission focused on providers and consumer strategy. Minister announced \$15M funding for home modification for older people living at home.

### ΑK

Working with NDIS on resolving claims that are not approved e.g. door opener deemed to be too costly. Also looking into other areas such as security doors for disabled people so that they can close doors and windows through home automation; working with regulator evaluating plumbing standards – shower hose, bidet, dual tech valve.

KV to contact AK to liaise on issues impacting national codes for submission to ABCB

# AΗ

Awaiting NDIS to approve applications. In the Aged Care space, we've experienced a local RAS provider (Catholic Care) that did not proceed with the tender incurring a significant impact on referral numbers.

#### LM

Supervising students from Western Sydney University at kitchen modification - looking at products, undertaking analysis for different injury types, starting with SCI from T6 up to C3. This will be on ongoing project depending on student placement availability.

iCare Home Modifications Team - looking into connections between smoke alarms and personal alarms, and ensuring back up power generation for those relying on home automation, especially life saving functions. All systems to comply with 2018 Electrical Standards changes.

Pilot project on Home Automation needs for people with severe injuries. Being headed up by Lisa McLean and Nick Taylor from iCare in conjunction with the iCare Home Modifications Team.

Governance: HMinfo Advisory Committee Meeting Minutes

### GK

Involved in SDA Reference Group consisting of 18 people and also involved in Transport NSW Wayfinding screens test for access for people with disability and aged care.

### DH

Representing OT Australia on the NDIS SDA Design Guidelines Industry Reference Group Review hosted by the Property Council. Discussing the NCC briefing noting the introduction of Changing Places toilets, which adopts a new class of public toilets. From May 1st, 2019, specified public buildings across Australia such as large shopping centres, sports stadiums, aquatic centres, museums, art galleries and airports must include an 'accessible adult change facility' that complies with design specifications mandated by NCC.

### SD

DVA major contract still on hold. In relation to NDIA, disputes for home mods are increasing due to a lack of clear guidelines. Stakeholder companies (e.g. building companies) are running SDA courses i.e. supported accommodation that participants in NDIS can rent. These have to be built to Platinum level.

### NL

Anecdotally, LAHC faces some pressures from hospitals seeking to discharge patients with a disability as LAHC's assessment of the property may result in the tenant requiring relocation to a more suitable property.
