NEW HMinfo RESOURCES

Review of early HMinfo publications to ensure currency with Building Codes

Since the inception of the Home Modification Clearinghouse in 2002, well over one hundred publications has been produced but the process of ensuring currency is never ending and at the end of last year the team confirmed that forty-two previously published documents required review and updating to cite the most current National Building Code and the associated building standards. Each of the forty-two publications that need updating will have the existing website publication download page updated to identify which standards are outdated and the relevant new standards to consult. All publications with outdated standards will also have a warning note attached to the publication, so users are aware that the document requires changes. These changes will be effective within a month.

The update process will proceed in a structured and prioritised manner, beginning with those referencing the oldest building standards—some dating back a decade such as documents like "access solutions to ramping" which need now to reflect the AS 1428.1:2021 Design for access and mobility, Part 1: General requirements for access - New building work. Major revisions may be required in some publications, although some updates may be very simple because although standards have been updated the part being referenced may remain unchanged, so it may require only a reference change. However, the more complex revisions will require both technical review and a new edition to be created.

The process of updating both website and the published documents must be completed alongside many other tasks by staff that are all part time. In terms of process, all republications will utilise our existing style guide and templates, with a focus on revising outdated content, correcting references, and ensuring consistency with current legislation and practices and subject matter experts will be consulted to confirm technical accuracy when needed.

Updates will be undertaken at a rate of approximately 3-4 publications per month. This pace allows for careful revision, internal review, and quality assurance before finalisation. It is expected that the full update process will take around 10 to 11 months.
