## 2.2 HMinfo Website Development

## Google Analytics:

Due to Google's decision to delete historic analytics data in July 2024, and the significant amount of HMinfo data residing on Google Analytics, it was necessary to develop an automated method for downloading and archiving the data. The automated method was finalised and was used to archive the data efficiently and accurately.

### DOIs generation & Drupal upgrade:

For the next few months, emphasis will be placed on completing the migration from ANDS to DataCite for the purpose of generating DOIs, as well as finalising the Drupal upgrade.

# **Suggestions**

 Home modifications in heritage-listed homes: Focus on one type of building (e.g., NSW terrace house) and describe 3-4 main types of modifications. One case study would be ideal. City councils to provide examples on how they deal with modifications. NL highlighted the problem of sticking to AS1428 for private houses, even though it is intended for public access.

### 3.2 Other Activities

 Letter to Bill Shorten to ask for funding to expand the audience of our research to include people with disability. DM said the NDIS review take much of the time and energy in the agency. He cannot comment on the agency research priorities.

KT reported on PDCN's experience of lack of clarity and communication on the priorities and consultation with consumers from NDIS.

- CHSP has requested the unspent funds from 2022-2023 back.
- HMinfo to apply for an ad hoc grant opportunity to add to our budget.
- HMinfo participated at the UNSW Future Health Expo on 14.03.'24.

## 4. Reports from Committee Members

SD Actions

 Highlighted the need for consistent training of OTs. OTA is currently providing OT training on environmental home modifications. Suggested HMinfo contacted OTA for funding so that HMinfo provides the training material.

### KT

 Key areas of focus for PDCN: 1. Co-chairing the Building Better Homes campaign in NSW with main focus on the adoption of the Silver Level Liveable Housing Design Standards in the NCC. 2. Renters' rights to home mods and conversing with the rental commissioner.

### DM

- · Senior leadership changes in NDIA.
- NDIS review recommendations the main focus currently.
- Procurement process review for home mods in SDA.
- Budget prices review for minor home mods.
- Social community housing space

### PM

- CHSP providers do not collaborate much.
- NDIS: The requests and approvals for major home mods has slowed down compared to last year. Ots requests for home mods are down as well.

KV to send link to PM for ready-made timber ramps.

• Ots/coordinators and people are not aware of the available providers/services. There is a need for promotion.

### NL

- Updating documents on home mods.
- New maintenance processes/app are developed.
- New CEO.
