Book Review: Landscapes of Care: Comparative Perspectives on Family Caregiving

Given the ongoing implementation of the NDIS in Australia, this book presents a timely summary and critique of disability service provision in other regions of the world. It focuses on family carers of adults with intellectual disability who live in the home, and particularly their 'socio-spatial experiences', from a human and cultural geography perspective.

The book is divided into 3 Parts: 1) Concepts of Care; 2) Comparative Perspectives in the Development of Care; and 3) Life Within the Landscape. Part 1 looks at the language of care and its different meanings, including formal and informal care, the different approaches to care taken by government, the disability movement, the carers movement, and the feminist movement, and the role of government and welfare. Part 2 compares government and informal care services in England, the US and Ireland, and compares the welfare ideologies in each country and how these contexts give rise to different 'landscapes' of care and disability that shape the experiences of individuals. It focuses particularly on care policy in Ireland, which is influenced by a blend of conservative Catholic family-based care policy and neoliberal legislative policy.

Part 3 examines the narratives of family caregivers influenced by these policies by analysing interviews with carers about their everyday experiences of caregiving and support services. This section of the book is by far the most compelling, describing in detail difficult transition periods such as from education services to adult disability services for young people with intellectual disability and their families, and critiquing the rationales for certain restrictions on the government carer allowance and respite grant in Ireland. This section highlights that particularly in the case of young adults with intellectual disability; caregiving is determined by the resources of individual families and the mix of community services available in the particular location. Regional inconsistencies in the way services are funded, organised and delivered is a major factor impacting the quality of life of people with disability and caregivers.

This is an excellent introductory text to those unfamiliar with the history of care provision in the reviewed countries (United States, England and Ireland), but will not necessarily add much knowledge or depth to readers well acquainted with the history and theory of care.
