1. HMinfo Website

Website Progress Report - in pack

CB explained the major upgrades that the website has undergone since the last ACM:

The website has undergone the following major upgrades since the last report:

1a) Colour Contrast Changes

Background and foreground colours have been adjusted across the website to ensure that the websites contrast ratios pass Level AAA requirements of the Web Content Accessibility Guidelines (WCAG) for small and large font sizes. Background images were adjusted where necessary to remove patterns which disrupt contrast ratios.

1b) ZoomText Rendering Options

ZoomText is a screen magnifier application which allows users to enlarge images and text on their desktop.

According to Vision Australia, the average magnification level is 400% and the most commonly used screen magnifier in Australia is ZoomText..

1c) Forum Search

A keyword based search was added to each Forum section on the website to enable users to conveniently find conversations.

1d) Calendar Enhancements

The HMinfo websites calendar strongly relied on pop-up windows to display event information. This has been replaced with whole pages on same page so people can read them without leaving the page.

1e) Mega Menu Enhancements

Previous enhancements to the Mega Menu addressed issues which would be experienced by keyboard-only users. The latest enhancements are aimed at addressing issues which were experienced by users of assistive technology such as turbo-mice.

A number of upgrades to the administrator interface were developed to improve productivity in regards to the management of website content.

6. Non-HMinfo Funded Projects:

CB provided the following update on other research projects undertaken by EBEP, but relevant to HMinfo:

6a) ARC Linkage: Livable Bathrooms - Designing out dependence in activities of daily living

This research is nationally significant and aims to establish the criteria needed for the development of more flexible, innovative and safer bathroom fixtures and domestic bathroom environments for older Australians. Bathrooms are for people, yet there is a lack of reliable and valid data to guide product innovation and the spatial envelopes required for efficient and effective bathroom design.

6b) City of Sydney – Liveability app.

The UNSW Liveability application is a tool that can be used on mobile devices, such as iPads, iPhones and Android phones, to collect audio, text, visual and image data about people's perceptions of their town centre.

6c) Literature Review: Mapping the evidence base on home modification outcomes - Phillippa Carnemolla

Status: The literature review has begun and research has been mapped onto a systematic Matrix. Evidence base is currently being analysed. .

6d) ACA - Building criteria, vision and luminance contrast

The project examines how people with normal and impaired vision with their physical characteristics identify and rate building elements possessing various luminance and chromatic contrasts in terms of their appearance and functionality.

7. Grants and Applications

7a) IRT Research Fund – application in partnership with the Community Housing Federation of Australia to look at home modifications in community housing using the Illawarra as the sample area.

Just missed out, came fourth, but didn't get the grant. But since then have been talking to South Australia and possibly applying there for a larger grant.

7b) DSS Healthy Ageing and Service Improvements

Grants – application to research and develop an evidencebased assessment and screening tool to assess the home environment of aged care consumers.

Status - Still awaiting approval - early next year

7c) DSS Healthy Ageing and Service Improvements

Grants – application for ongoing funding to run HMinfo **Status** - Still awaiting approval – early next year

7d) DSS Housing and Homelessness Grants –

application to develop an evidence base and Smartphone app to assist home modification providers and young people with disability (YPD) and their families to determine whether assistive technology (AT) or home modifications (HM) would enable secure accommodation options that provide the best long term support to minimise YPD's ongoing care costs and maximise their independence and community engagement.

Status - Still awaiting approval – early next year

8. Other Business

8a) Home and Building Insurance – website statement, potential publication

HMinfo has put a statement on our website, plus are currently collating a list of insurance companies for future publications.

8b) Potential (HMinfo website) publication: Elimination **Steps** – HMinfo Team (JQ Proposal)

Committee Members start a list of ways small steps with lips under 20mm are resolved in practice.

Hamish mentioned how builders often dictate how to solve issues for clients that are not practical and that the building footprints should be changed from day one. Eg: plan wider doorways to begin with. Council regulations have stipulations that are inflexible on changing their rules.

Should we be looking at changing this publicaton? The reply was no, it's industry driven.

8c) Project requests from Advisory Committee

Nut out a strategy to discuss housing guidelines, adaptability and building guidelines. Could be on our agenda to identify cases which require changes to legislation

There is a need for education and making people aware of these needs. New house construction is only 3% but home mods is the majority area. There's a greater need for both builders and consumer education.

Suggestions were also made in response to the previous Minutes to inform consumers with factsheet/guidelines.

NC: in a) for consumers to select builders who are wheelchair access competent, b) that guidelines like the Livable Housing Australia's Design Guidelines are available to the new home buying public, and c) to educate small home builders the design changes to their project homes that will economically accommodate access in new homes.

Finally, with the Access to Premises Standards now incorporated in the NCC/BCA, new residential flat buildings now have disability access to common areas. Together with lifts new residential flat buildings are providing higher level of access than single cottages.

Organise a joint meeting PDC with Home Mods State Council and PDC to nut out a strategy for this.
