They put out a survey and found that tradies were inclined to "ask a mate" in the industry to get help rather than call the help line.

Website Progress Report

Home Page Re-design - Feedback received by staff members who frequently support users in finding information on the website was critical in designing the new home page.

Screen Reader Compatibility Improvements:

Form Layouts

- Adjusted layouts
- Replaced symbols

Service Directory

- Services are listed using a new layout
- Consolidated links to service information.

Website Platform Upgrade

- Higher cross-compatibility
- · Optimised rendering on mobile devices.
- Improved accessibility by allowing sections and functions of websites to be explicitly defined to screen readers.
- Reduced form validation errors by providing strict input controls for specific types of information such as phone numbers and email addresses.
- Newsletter Wizard uses templates to automatically generate a standardised newsletter based on content provided by staff.

2 a. Summary Bulletin & Consumer Factsheet: Fire Safety – Smoke Alarms

The Summary Bulletin and a new Consumer Factsheet have been reviewed by the Specialist Review Panel. C. Bridge confirmed that Fire Brigades were represented in the review. Copies of the Summary Bulletin and new Consumer Factsheet were circulated in the meeting. The Consumer Factsheet was also included in the document pack for feedback from Advisory Committee members.

5. Non-HMinfo Funded Projects:

5a. ARC Linkage: Livable Bathrooms (Caroma) – Caroma has taken out 5 new patents for new products as a result of some of the data already collected. There is ongoing difficulty finding people 85+ for lab testing.

5b. DIY Home Modifications: Point of Sale Support for People with Disability and their Carers

DIY Home Mods paper should be ready for peer review end of June.

Teresa Petric suggested resources to be developed as outcome of this research will be useful to all hardware stores, and also suggested there may be some opportunities to take this further.

5c. Building Criteria, Vision and Luminance Contrast – ongoing PhD project funded by Access Consultants Assoc. is currently in progress.

Teresa Petric suggested HMinfo uploads the videos from the project on our website. We will look into doing that on completion of the project.

5d. City of Sydney – Livability app was used as an auditing tool both prior and after the Crown Street Upgrade. We have entered into the "Walking Visionaries award".

5e. Moving to my home: housing aspirations, transitions and outcomes of people with disability report (AHURI funded). Investigates the barriers and also success factors enabling people with disabilities to move into housing more suitable for their needs.

Michael Bleasdale spoke about a workshop he attended which looked at the NDIS funding discussions to get the most value and benefits from the proposed budget. Catherine Bridge spoke in more detail about the project.

There was concern raised by Max Bosotti and Nicholas Loder that a lot of people with special needs would be excluded from NDIS funding. e.g.: people with dementia and intellectual disabilities.

6. Other Business

a. DSS has extended our contracts to March 2016.

Max Bosotti suggested we make an application to the NDIA Quality and Safeguards framework.

Michael Bleasdale talked about research on voice activation applications for homes for activating household devices e.g. turning on light switches or activating fire alarm at fire station base.
