1. HMinfo Website

Website Progress Report - in pack

The website has undergone the following major upgrades since the last report:

High Contrast Mode - Background and foreground colours had been previously adjusted across the website to ensure that the websites contrast ratios pass Level AAA requirements of the Web Content Accessibility Guidelines (WCAG) for small and large font sizes.

Although previous changes aid a significant amount of users and comply with standards, there are users who require contrast to be further increased to improve the websites readability.

A High Contrast Mode was added to the website which alters colours and certain images.

Users may switch contrast modes via a new toolbar in the websites header.

Improved Coverage Area Options

Local Government Areas (LGAs) are the primary means of specifying the coverage area for services listed on the websites Service Directory.

User feedback suggested that a minor amount of services were listed in areas which they did not service. Upon investigation, some services were found to be located in postcodes which are within the boundaries of two or more LGAs.

The coverage area options provided to users has been improved by allowing users to exclude individual LGAs from their listing. If a service's postcode is located within overlapping boundaries of multiple LGAs, the user may select the preferred LGA by excluding the alternative areas.

In order to simplify the designation of coverage areas for users of assistive technology, configuration forms have been divided into separate steps.

The upgrades enhance the accuracy of the Service Directory search and the user experience during service configuration.

Upcoming website development:

- Continuation of screen reader testing and related website adjustments
- Home page layout redesign to improve the visibility of important links
- Continuation of website modifications detailed in the HMinfo Website Action Plan

There was much discussion re the My Aged Care Changes and how unprepared they were at the conference. MT spoke about how community

based OT's are shrinking and more OT's are being privatised. Also that many clients are now not eligible for any NDIS help. HACC Govt have also lost many health workers including OT's.

6. Non-HMinfo Funded Projects:

CB provided the following update on other research projects undertaken by EBEP, but relevant to HMinfo:

6a) ARC Linkage: Livable Bathrooms - Designing out dependence in activities of daily living

This research is nationally significant and aims to establish the criteria needed for the development of more flexible, innovative and safer bathroom fixtures and domestic bathroom environments for older Australians. Bathrooms are for people, yet there is a lack of reliable and valid data to guide product innovation and the spatial envelopes required for efficient and effective bathroom design.

6b) ADHC "DIY Home Modifications: Point-of-Sale Supports for People with disability and their Carers" - Nicole McNamara, Sophie Maalsen & Catherine Bridge

- Positioning Paper circulated at previous meeting

Status: The DIY home mods project is due to be completed in June 2015. We have completed the interviews and survey component of the data collection and recently conducted a forum with consumers and industry plus an ethanography and are now in the process of writing the final report.

TP talked about the forum and how large the marketshare is for just 5 products. Also the fact that Bunnings came but not the other hardware stores.

6c) City of Sydney - Liveability app.

The UNSW Liveability application is a tool that can be used on mobile devices, such as iPads, iPhones and Android phones, to collect audio, text, visual and image data about people's perceptions of their town centre.

7. Other Business

7a) Home and Building Insurance – website statement, potential publication

MB talked about the insurance – home building regulations in NSW recently amended including an exemption for providers of home mods services under HACC exempt from taking out home owners warrantee insurance in NSW. The Home building regulation has been amended to change wording to make clear that it's only State funded HACC services eligible for exemption as of 15th Jan 2015. There is a still a 2 tiered system – anything under \$20,000 won't require an insurance, but anything over that value funded through Commonwealth will require home owners insurance. Only 4-5 bodies across the state have this. Only those funded by the state are exempt – (different in each state). (NSW -Over 65's funded by HACC are not exempt and under State – under 65 - ADHAC are exempt).

GK suggests a fact sheet with tick boxes are supplied to consumers to sign off to implement the best outcome.

MB suggests a webinar with HMinfo & DSS to inform people throughout the country to see differences in each State.

NL alerted HMinfo to a recent general précises of the legal implications of home building refirm in NSW from Clayton Utz lawyers that needed to be shared with website users.

8c) Project requests from Advisory Committee

SD – raised question if there are general guidelines to building/home mods factsheets? Potential to develop with Architects a "Kit of Parts" for residential homes. (We have started a block library) There is already some for industry or commercial buildings. There is no way of creating a single guidance fact sheet as each person requires different individual needs
