# 3 Clearinghouse website expansion / knowledge developmet

Jane offered a vote of thanks and congratulations to the HMMInfo Clearing House team on the successful website launch held 6 November in Manning House at Sydney University.

The status of ongoing Systematic Reviews by the Clearinghouse team was discussed. This included

 Delayed completion of the grab rail diameter review due to preparations for the website launch. The revised date for issue to the Specialist Review Panels is earlier December.

 Reviews on alarm systems for hearing impairment and slip resistant coatings for tiles are now underway by the team's two new Honours Students. Ongoing supervision of students **KB** 

 Meagan Dewitt, a student from University of Florida, will be working with the HMMInfo Clearinghouse as part of formal exchange program. It is anticipated that Meagan will also undertake another systematic review

Webstats, the website usage monitoring program utilized by HMMInfo, has demonstrated a steep increase in the website usage since August

#### 4 Clearinghouse Sector Training

Sector training has commenced with planning for further training underway. Training focuses on familiarization with the website and effective and efficient use of the website

Anne suggested Illawarra and Queanbeyan be grouped together for training i.e. incorporated in the Southern Region meeting.

Katy suggested that the HMMInfo team would develop and provide a handbook to accompany future training programs.

Produce handbook **KB. PP. JC** 

Anne suggested a glossary be included for those who not familiar with IT jargon.

lan continued that the handbook should be uploaded onto the website under a 'help' menu. Reference to the handbook should also be included in the 'Tour'.

#### 5 Clearinghouse Promotion

Attendants reviewed the handout on website promotion. This was followed by a discussion on additional promotional strategies.

- Pensioners and Superannuates Association Production and issue of flyers to
  - Council libraries where seniors can then use library computer if don't own one
  - Disability Information Network, a librarians' information service that meets at the NSW State Library

#### 6 Other Business

Katy met with Sue Slattery from ILC is relation to grab rail information on 18 November. The ILC is running a workshop for OTs on grab rail issues. The workshop is sponsored by Lenlok.

Katy and Julie met with Bill Reynolds from Lenlok on 18 November in relation to possible research collaboration.

- Ian Maxwell pointed out that the new textured finishes grab rail suppliers were producing become increasingly hazardous overtime. He queried if there was a possible avenue of communication to the suppliers through the Clearinghouse to support evidence based production of new grab rail products.
- Anne asked if it is possible to commission a specific grab rail, possibly with State Council backing / support due to the potential advantage of group buying for all HMS. HMMInfo Project could 'signoff' on several good rail designs. Ian stated some group buying already exists
- The HMMInfo Strategic Plan is currently being written. The Plan will be presented at next Advisory Committee meeting

Complete plan **KB**, **PP**, **JC** 

 Jane stated ILC Kitchen and Bathroom books will be made available to all HMS in the Resource Library 'Private Area' on the HMMInfo website. Katy suggested that additional comments requesting feedback on these publications might be useful.

Upload publications **JC** 

 As the Project Advisory Committee Terms of Reference were accepted they are now available on the website in the Administration Library.

Upload document JC

Expansion of membership for the Project Advisory Committee
was discussed. Anne and Ian suggested construction
industry sector representatives such as Master Builders
Association, Housing Industry Association be included. Also
representation by Commonwealth Rehabilitation Services may
be appropriate. The recommended approach to candidates
included an invitation to the May Advisory Committee meeting.
In addition the HMMInfo team should consider the potential
benefits to the candidates rather than focusing on benefits to
the project.

#### **Actions**

Identify and contact relevant candidates **JC** 

Jane asked if Adaptable Housing issues were relevant to HMMInfo project. She asked who keeps a register of where and what Adaptable Housing is available? Peter and Ian informed the attendants that Councils keep a record of 'approved' adaptable houses. Furthermore under the new title system Council's are using, post adaptation drawings are a required component of relevant Development Applications. There is a 3 year sunset clause before this system is mandatory. Currently it is self regulating.

 Anne asked for feedback on a question posed by a client: Have 'Choice' ever done review of home modifications? Attendants were not aware of any review to date. However, a review of assistive technology had been completed in collaboration with the ILC. Representation to Choice magazine **KB**, **PP** 

A review of home modification was generally considered a useful idea as a future article or special issue on home modifications. Choice published an article on hidden traps and costs relating to retirement villages.
