Period: November 30, 2016 to February 28, 2017

The HMinfo Website Report was included in the Advisory Committee Members' document package. The key statistics, include:

Total Page Views to Date: 1,069,467

(Increase of 13,041 from last meeting's total: 1,056,426)

Total Visitors to Date: 321,016

(Increase of 5,293 from last meeting's total: 315,723)

Total Registered Users: 1,761

(Net increase of 23 from last meeting total: 1,738)

Listserv (OT Mailing List) members: 624

(net increase of 10 from 614)

b. HMinfo Website Progress

The HMinfo Website Plan 2016-2017 was approved during the last reporting period. The following tasks have been actioned this period:

- Online forms to allow users to anonymously submit feedback regarding HMinfo publications
- Faster service directory loading times to improve the websites usability
- Website structure modifications to accommodate up to 9 top-level menus (included adding a side navigation menu on each page to simplify navigation)
- Website content update for new landing pages
- Menu design update to help users identify menu navigation controls, layout

The following tasks are in progress and are due within 7 days:

 Setting larger default font sizes and increase line spacing across the website to improve legibility

Upcoming tasks:

- Discuss possible improvements to the website search control and search speed
- Device resolution responsiveness added to the website to improve usability on non-desktop devices such as mobiles and tablets
